

2 Individual tax status (continued)

Suitable documentary evidence can consist of any of the following:

- A copy of correspondence between you (or your professional advisers) and the relevant tax authority in your 'Country of residence' in which the tax authority confirms your non-domiciled status or tax-exempt status as appropriate
- A letter addressed to us by your professional adviser (accountant or lawyer) confirming your non-domiciled status or tax-exempt status in your 'Country of residence'

Note: We reserve the right to refuse any information provided as evidence that appears not to be appropriate and we will retain tax from the interest paid to you.

Please note, if you **do not** tick one of these boxes and you have stated that you are resident in the European Union, we are required by law to retain the tax from the interest paid to you.

- 1.2 If you have selected C, that you are a European Union passport holder, but your permanent residential address is not in the European Union, you are within the scope of the legislation and it may be necessary to treat you as being 'resident' in the country that issued your passport, unless you can prove that you are not resident in the European Union. We may require additional proof from you to confirm this.

- 1.3 If you have selected D, that you are not a European Union passport holder nor are you resident in the European Union, you are outside the scope of this legislation and are not liable for tax on your interest under this law. However, we recommend that if you are in any doubt about your personal tax circumstances, you should seek appropriate professional advice.
